#### **Best Practices or Bad Habits?**

Happy New Year!!! While I am not a big fan of the New Year's resolution — there are many people who believe in starting the year resolved to change their habits. My perspective is if you need to make a change, why wait until the new year? I prefer to pick a theme for the year.

In 2018, PAISBOA focused on member engagement, and in 2019, we are focusing on group purchasing. PAISBOA was founded on the concept of group purchasing, with a mantra of "all for one, one for all", and with the core values of integrity, transparency and loyalty. This back to basics approach, with a fresh perspective from the PAISBOA Services Corporation Board and Purchasing Consortium Steering Committee, will serve our members well as we assess our group purchasing programs in the coming year.

As the business officer portfolio continues to expand and become increasingly complex, and the economic environment continues to change and evolve, business officers who "seek competitive advantages by implementing widely accepted best practices, or by following playbooks that distill conventional wisdom, may be destined for mediocrity." Relying on "the way we've always done it" in this era of uncertainty may detrimental to our schools and universities.

In their book, Detonate: Why - and How - Corporations Must Blow Up Best Practices, Geoff Tuff and Steven Goldbach from Deloitte share four guiding principles for adopting a new mindset to break old habits. They also identify specific areas—in risk management, strategic planning, financial forecasting and budgeting, syndicated data, traditional insight generation, celebrating failure, org charts and career paths that should be targeted for "controlled detonation":

- 1. Focus on human behavior not the numbers
- 2. Bring a beginner's mind adherence to accepted principles, no matter how well they have served you in the past, end up restricting options and obscuring possibilities
- 3. Embrace impermanence –volatility, disruption, and change are here to stay
- 4. Build minimally viable moves to test and learn rather than go "all in," incrementally and economically innovate step-by-step

They go on to talk about how Business Officers can help drive change in their organizations:

- 1. Ask better questions What would it look like if we didn't do things that way?
- 2. Create a portfolio of innovation look away from the core and closer to unknown territory
- 3. Make budgeting adhere to strategy basing budgets on a calculation of how much it costs to nudge customers into engaging into behavior that results in added revenue
- 4. Switch to zero-based budgeting We are fortunate to have a couple of experts in our midst who can help—Lisa Carbone Warren from Moorestown Friends and Carol Lerner from The Philadelphia School presented a webinar to PAISBOA members and presented at the NBOA Annual Meeting on zero-based budgeting.

It is not too late to start the new year and determine if your "best practices" are serving your needs or is it time to question conventional wisdom and confront the underlying assumptions that drive decision-making at your school and university? We flipped the classroom, is it time to flip the cultural orthodoxy that is pervasive and goes unchallenged?

What do you need to start your own "controlled detonation"? Perhaps you should assess your purchasing relationships based on the new information you received from our vendor partners at the Purchasing Consortium Annual Meeting this week? You may want to explore the new options presented by our vendor partners and try a new source for the goods and services you require, knowing that the vendors have been fully vetted by your PAISBOA colleagues.

In the next couple of months, PAISBOA is going to provide several professional development opportunities for business officers and their teams - HR, Plant and Operations, Technology and Sustainability - to come together in-person and online to explore the answers to some of these questions and more. As always, PAISBOA stands ready to support you and your team, and your colleagues are just a phone call or e-list post away.




# **SUSTAINABILITY**

#### Schools, Climate Change & Solutions is topic of Jan. 15 Meeting at Ancillae-Assumpta

Thirty-three participants from 17 schools attended PAISBOA's Sustainability Group meeting at Ancillae-Assumpta Academy on January 15, 2019; the topic: Schools, Climate Change & Solutions. Climate Reality Leadership Corps member and Haverford College's Vice President & Chief of Staff Jesse Lytle gave a solutionsoriented presentation on climate change.

Ancillae-Assumpta Academy's Director Amy Lintner and Assistant Principal **Eileen Wolpert** shared a brief history of the school's environmental stewardship commitment, symbolized by photos of the "blue planet" hanging in





Jesse Lytle's presentation on climate change covered plenty of facts and solutions. Some takeaways include:

- Climate change affects extreme weather patterns (17 of the 18 hottest years on record occurred since 2001), food supply (decreased yields of crops), health (heat related deaths), environmental degradation (50% of land-based species risk becoming extinct by the end of this century), carbon costs (#1 threat to global economy).
- Globally, we dump 110 million tons of greenhouse pollution in the the atmosphere every 24 hours. That is equivalent to 400,000 Hiroshima atomic bombs dropped per day for 365 days per year.



The good news is there are solutions:

- · Costs to generate green energy (wind and solar) decreased as energy capacity increased
- In PA, there are twice as many jobs in clean energy as there are in fossil fuels
- 62% of Pennsylvanians believe climate change is causing problems
- · Governor Wolf established the first statewide goal to reduce carbon pollution in PA.

The evening ended with a raffle prize of Paul Hawken's book Drawdown -- 100 solutions to reduce global warming. Anne-Marie

McMahon of Delaware Valley Friends School noted, "This event was just excellent overall, inspiring, and well done."
